Subject:- **Compliance of Hon'ble High Court of Rajasthan Judgment Order dated 17-5-2017 in S.B. Civil Writ Petition No 2867/ 2017 of Kashi Ram Vs Uol and Anr and other linked cases relating to Constable(GD) 2011 Examination – reg.**

In compliance of Hon'ble High Court of Rajasthan Judgment Order dated 17-5-2017 in the matter of S.B. Civil Writ Petition No 2867/ 2017 of Kashi Ram Vs Uol and Anr and other linked cases relating to Constable (GD) Examination 2011, Commission had invited the detailed representations from the aggrieved petitioners by 27.09.2017, called them for Personal Hearing in batches from 04.12.2017 to 22.12.2018 and issued Speaking Orders to all of the aggrieved petitioners by the end of April, 2018.

2. However, in the meanwhile, a number of other writ petitions have also been disposed of by the Hon'ble High Court of Rajasthan in terms of Judgment Order dated 17-5-2017. In this respect, the Commission has received **243 detailed representations** from the aggrieved Petitioners by 04.05.2018. After duly examining these representations, the Commission has now decided to give an opportunity for Personal Hearing to the aggrieved Petitioners.
