Junior Engineers (Civil, Mechanical, Electrical and Quantity Surveying and Contract) Examination, 2015 – Declaration of Final result

The result of Paper-II (Descriptive Paper) of Junior Engineers (Civil, Mechanical, Electrical and Quantity Surveying and Contract) Examination, 2015 was declared on 16.12.2016 for Document Verification.

2. After fixing of cut-off on the marks in Paper-I, 6788 candidates qualified for evaluation of Paper-II of Civil Engineering and 1801 candidates qualified for evaluation of Paper-II of Electrical/Mechanical Engineering on the basis of marks obtained in Paper-I.

3. After fixing of cut-off on marks in Paper-II, 3291 candidates qualified in Civil Engineering and 836 candidates qualified in Electrical/Mechanical Engineering for Document Verification.

4. Candidates were allocated amongst various posts keeping in their merit-cum-preference. Keeping in view the vacancy position, category-wise details of the 1572 candidates qualified in Select List for appointment to the posts located in different Departments are given below :-

5. Resolution of Tie Cases – Tie cases have been resolved by applying the following criteria in the given order till the tie is resolved :-

- (i) Total marks in written examination.
- (ii) Marks in Paper-II.
- (iii) Marks in Paper-I.
- (iv) Date of birth, with older candidates placed higher.
- (v) Alphabetical order in the first names of the candidates appear.

6. There are some candidates whose candidatures have been kept as provisional by the concerned Regional Offices but are also included in the Select List. Concerned User Departments will check the eligibility of such candidates thoroughly at the time of nomination. One SC vacancy has not been filled up due to a pending court case.
